The Inspectors of Election, LLC (TIE) was contracted to serve as the oversight authority and independent, thirdparty election service for Ladera Ranch Sommunity Services Election of Directors

As the duly appointed Inspector of Election at the Selection Meeting of Ladera Ranch Community Services held on the date noted above and all adjournments thereto, we hereby report as follows:

Quorum for the Annual Meeting:

- 1. The total Membership is 7237 and the number of Members in good standing and entitled to vote on matters at the Annual Meeting was 7237 in 121 Neighborhoods and 7 Apartments.
- 2. No members were duly suspended.
- 3. It was determined that a quorum of 25% of the community represented by Neighborhood Representatives was obtained as defined by the Bylaws. Specifically, 28 Neighborhood Representatives representing a voting power of 1827 (25.25%) were present in person to establish quorum.

Supervision of Election

- 1. TIE reviewed and supervised the registration and voting process.
- 2. TIE provided an online voting platform for members to cast their vote for the Election of a Director.
- 3. TIE certifies that the votes were cast as reflected in **EXHIBIT A** on pages 4 through 7.

Election Process

- 1. There was one (1) vacant position open for election on the Board of Directors at the Meeting.
- 2. The term for the open position was for three years.
- 3. Ladera Ranch Maintenance Corporation bylaws allow for cumulative voting.
- 4. The Candidates were as follows and the votes received by each candidate is listed inline with their name as carried forward by all Neighborhood Representatives (Review <u>Exhibit A</u> for Full Description):
