In accordance with California *Civil Code* Section 4360, the Board of Directors hereby provide you with a minimum of twenty-eight (28) days' notice of changes to the Fee and Fine Schedule, which are proposed for adoption at the Open Session Board of Directors Meeting for the Ladera Ranch Maintenance Corporation ("LARMAC") on July 9, 2025, at 6:00 p.m., at the Oak Knoll Clubhouse, located at 28192 O'Neill Drive, Ladera Ranch, CA 92694. The purpose of this notice is to offer you an opportunity to provide comments on the proposed changes.

In response to resident feedback, significant improvements were made to the outdoor space at the Oak Knoll Village Club. Residents will now be able to reserve the new outdoor space for birthdays and other celebrations by itself or in conjunction with a clubhouse reservation. These improvements include:

- New functional turf area
- Irrigation and drainage modifications for improved functionality
- Beautiful magnolia trees to compliment the Craftsman style clubhouse and other landscape enhancements
- New and improved landscaped paver walkway and seating area
- New polished concrete counters with stainless steel ice coolers
- Additional seating areas with new patio furniture. This includes large picnic tables that will seat up to eight (8) as well as cushioned seating.
- Overhead lighting for ambiance after sundown. Overhead lighting was also added to the corn hole area on the other side of the clubhouse.

This is your opportunity as a member of LARMAC to provide feedback on the proposed revisions to the Fee and Fine Schedule before the Board's formal vote on adoption. The Board of Directors will take all comments into consideration prior to voting.
